The **TAE40122 Certificate IV in Training and Assessment** is the industry standard qualification for those who deliver and assess training.

The TAE40122 Certificate IV in Training and Assessment reflects the roles of entry-level vocational education and training (VET) teachers, trainers and assessors who are delivering training services to vocational learners and assessment services to candidates. The roles may be undertaken by those working in registered training organisations (RTOs), enterprises, community organisations, schools and other VET contexts. This qualification meets the minimum education requirement for trainers and assessors operating without supervision under applicable VET legislation, frameworks and/or standards. A Road Map has been provided with the suggested order of study. Chat with one of our trainers if the plan or dates don't work for you. You will find our schedule of workshops for each block of units in the course breakdown.

ENTRY REQUIREMENTS

Those entering this qualification must be able to demonstrate vocational competence in their proposed training and assessing area. Vocational competence is defined as broad industry knowledge and experience, and may include, but is not limited to, holding a relevant unit of competency or qualification. This information is gathered when you complete the questions on pages 8, 9 and 10 in this document (and send them in). There are 12 units in the TAE40122 Certificate IV in Training and Assessment, 6 core units and 6 elective units. Our unit selection reflects the needs of industry with a focus on supporting learning in a variety of ways in the workplace.





BEFORE YOU BEGIN

A Certificate IV in Training and Assessment is one of the more challenging qualifications to study and requires a large time commitment in order to successfully complete the course.

TAE students are usually experts in their field - meaning you are unconsciously competent at what you do. When you join us to complete the learning required as part of the TAE, generally our participants have some experience in industry but less experience and exposure in the Vocational Education and Training context. This requires you to go back to basics and build knowledge from the ground up. learning new knowledge and skills for each unit of competency. Sometimes you have existing knowledge that we can build on, other units it's completely new content. This can be confronting and is definitely time consuming at times. We have scheduled our workshops so that you can have as much time face-to-face with a trainer as possible, as this makes it much easier to move through the content quickly. However, you can also choose to complete any combination of units as a self-paced students, offering you complete flexibility.

Before you start it is important to ask yourself the following questions to determine if this is the right course for you.

- Do you have any previous training and assessment qualifications? If yes, include these with your enrolment form.
- Have you considered recognition of prior learning?
 If so, then please ensure you are familiar with what it entails and the required process.
 Please contact the administration team to discuss this further.
- Have you discussed with our team any extra information that needs to be considered for you to complete the course?
- Do you have access to the appropriate practice and study environment that is required for the completion of the course?
- Your success will be enhanced if you can access a study area with two screens, a camera and a headset with a microphone. If you have a laptop the inbuilt camera and microphone will work you will just need a quiet space to join us online.
- Do you have the required technological skills in order to undertake the program? As a Trainer and Assessor you will be required to fill out paperwork, write training plans and read assessments on a daily basis. Can you navigate your way around the internet, download documents, upload files, etc There's a small checklist on the following pages to gather further information from you on this front.
